## MACLUUMAAD KU SAABSAN JOOJINTA FAA'IIDOYINKA

Shuruucda dheefaha sii socda way ku kala duwan yihiin barnaamij kasta oo manfacyada bulshada ah **Xaaladaha badankood, hay'adda dowladda / waaxda degmada ayaa ah inay sii wado dheefaha haddii aan helnay rafcaankaaga kahor taariikhda ay wakaaladda kuu sheegtay inay joojinayso ama yareyn doonto dheefahaaga.** Taariikhdaas ayaa laga yaabaa inay ahayd ka hor xilligii loo qabtay ee racfaanka. Si kastaba ha noqotee, waxaa jira waxyaabo ka reeban. Tusaale ahaan, dheefaha sii socda ee gargaarka cuntada lama heli karo ka dib dhammaadka muddada caddeynta, iyo faa'iidooyinka sii socda lama heli karo haddii ay *dalab* wixii macaash ah la diiday.

Haddii hay'ad ay diido inay bixiso dheefaha joogtada ah oo aad weli aaminsan tahay inaad xaq u leedahay inaad hesho, waxaad na weydiisan kartaa inaan dalbanno dheefaha sii socda. **Codsigaaga sii wadista dheefaha waa inuu ahaadaa qoraal waana inuu sharraxaa cidda aad kala hadashay hay'adda dawladda iyo waxa ay kaaga sheegreen codsiga.** Haddii aadan sidaas sameyn, waa inaad sidoo kale noo soo dirtaa nuqlu ogeysiiska aad heshay oo kuu sheegaya in dheefahaaga la dhimi doono ama la joojin doono. Haddii dhagaysigu yahay **foolka-fool**, Dhinacyadu waa inay ka hubiyaan soo dhaweynta qolka dhagaysiga ee Dabaqa 4<sup>ta</sup> ee xafiiska Maxkamadaha Maamulka ugu yaraan 15 daqiiqo kahor waqtiga dhageysiga la qorsheeyay. Waxaa lagugu hagaajin doonaa qolka dhagaysi ee lagugu qoray.

Haddii dhagaysigu yahay **dhageysiga taleefanka ah**, Dhinacyadu waa inay ku shiraan goobta lagu cadeeyay Ogaysiska Dhageysiga ugu yaraan 15 daqiiqo kahor waqtiga dhageysiga la qorsheeyay. Haddii aad diido dhageysiga taleefanka oo aad rabto dhageysi fool-ka-fool ah, ku ogeysii Garsooraha Sharciga Maamulka ("ALJ") dalabkaaga si wanaagsan kahor taariikhda dhageysiga. Nuql codsigaaga u dir dhinaca kale.

Haddii dhagaysigu uu yahay mid taleefan ah oo aad rabto inay ALJ eegto dukumiintiyadaada, fadlan u dir nuql dukumiintiyada dhegeysiga ka hor, iyo nuql kooxda kaa soo horjeedda. Waa inaad u dirtaa nuqullo la akhrin karo, oo aan ahayn kuwa asalka ah, wixii dukumiinti ah ee aad u baahan tahay dhageysiga ka dib.
